GENERAL CHARACTERISTIC

LU-1432 is produced from potato tubers in the process of mechanical grinding, washing out and refining and then starch is dried with a stream of hot air to the maximum moisture content of 20%, and granulated. In boiling water granulated starch does not form lumps, it disperses evenly and thickens the product. LU – 1432 should not be used in acidic products with a pH value < 5. It is particularly recommended for: food concentrate products as a thickener for instant soup.
