#### **GENERAL CHARACTERISTIC**

LU – 1420 is a product of esterification of potato starch with acetic acid anhydride. It has better functional properties than potato starch. Aqueous solutions of LU - 1420 form transparent paste with a long structure, characterized by low gelatinisiation temperature and high stability after cooling down. However, they are not resistant to high temperature, acids and coagulation forces (intense stirring).

It is particularly recommended for the production of: instant noodles, frozen fruit pies, filling for confectionery goods, baking and confectionary goods, protective coating for dried vegetables, sauces, soups, powdered concentrates, flavoured and thermised yoghurts and thermised cottage cheese.
